#### **GUJARAT SELF FINANCED SCHOOLS (REGULATION OF FEES) ACT, 2017.**

**No.GH/SH/06/BMS/1118/83/CHH:-** WHEREAS, in exercise of the powers conferred by sub-section (1) of section 9 of the Gujarat Self Financed Schools (Regulation of Fees) Act, 2017 (Guj.20 of 2017) (hereinafter referred to as "the said Act"), the Government of Gujarat has specified the amount of fees for different categories of self financed schools vide Government Notification Education Department No. GH/ SH/ 20/ BMS/ 1117/ 83/CHH, dated the 25<sup>th</sup> April, 2017 (hereinafter referred to as "the said notification");

AND WHEREAS, Hon'ble the Supreme Court of India in SLP (c)No.314/2018 vide its order dated the 1<sup>st</sup> February, 2018 issued direction to the State Government to carry out the exercise of fixing exemption limit under section 9 of the said Act ;

AND WHEREAS, the State Government had constituted a five Members Committee headed by the Chairman, Gujarat Secondary and Higher Secondary Education Board to carry out the exercise for fixing the exemption limit as per the directions of Hon'ble the Supreme Court and submit the Report with its Recommendations;

AND WHEREAS, the Committee so appointed has submitted its Report with Recommendations to the State Government;

AND WHEREAS, the State Government has considered the Report and Recommendations submitted by the aforesaid Committee;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 9 of the said Act and in supersession of the said notification dated the 25<sup>th</sup> April, 2017, the Government of Gujarat hereby,-

- (i) specifies the amount of fees, with effect from the academic year 2017-18, specified in column (3) of the Table shown below ( hereinafter referred to as "exemption limit") for the category of self financed schools respectively specified in column (2) of the said Table;



(ii) declares that the schools charging the fees lower than the exemption limit as specified in column (3) of the Table shall be exempt from the determination of fee by the Fee Regulatory Committee;

(iii) directs that the schools charging the fee more than the exemption limit as specified in column (3) of the Table shall be required to submit the proposal along with the accounts and documents for determination of fees to the Fee Regulatory Committee in accordance with the provisions of the said Act and rules;
